**Portfolio Commentary**

During July 2014 Cadence Cayman Fund returned a positive net performance of 2.46 % compared to an increase in the All Ordinaries Accumulation Index of 4.49% and an increase in the Small Ordinaries Accumulation Index of 4.91%. For the past 4 years and 7 months, the fund has returned a positive annualized net performance of +17.10% per annum compared to an increase in the All Ordinaries Accumulation Index of +7.55% per annum.

The fund finished the month 68.33% net long. The net exposure for June 2014 was 64.71%.


## Historic Strategy Performance & Exposure - 8 Years
